2. CEO REPORT FOR MAY 2025

- Contacted Eastlink for another Eero box to see if that would help with the security cameras outside and ended up getting another one free of charge, free long distance as well as a \$50 a month saving.
- ➤ We received \$1400 from Plant Youth for Tabletop Role playing games and Card related game. The purchase of Dungeon and Dragons, Magical Kitties and Humblewood have been made, and character building has started. We have also purchased Pokémon's card for games that we start on May 31.
- ➤ We also received \$1500 from Legacy Grant to upgrade the patron computers and video games. The computer upgrades have been completed we now have 4 patron computers as we converted the 2 old office PCs to the patrons stations.
- ➤ I have not heard back for the Frogs Breath Grant yet. Update we did not receive the Grant this time around.
- ➤ Historical Society will be working with us in June to help us preserve or historical/archive section of the library.
- Latchford is working on the contract and funding to join us they are just waiting to hear back with information from Coleman
- ➤ Homework Buddy for Tuesdays is working out well. Ken has a group come in work on different projects.
- We have made the Lego Club to open to all ages and cut it down to once a month. This way we can try new things to see if we can get others in.
- > Tech help- we have only had a few people in for this expertise, but we do have more coming in for the use of computers.

> We have craft days, board game days and electronic game days. We are looking into

trivia night social, book clubs. We have offered a couple of book clubs with no

response.

We are still working on making sure all the books are Cataloged properly for

reporting. The Children's section is completed and rearranging this section is

almost done.

> We are still waiting for the town to come in and put the covers for the lighting up and

to see if they know where the other covers are. I phoned the Town again on May 28

still no ETA.

to be added to the account. I will be working with Tamara to get this rectified this
